We take this opportunity to introduce ourselves as proud Indian International Health, Safety & Environment Specialists.

Our objectives of Being Vocal for Local for Best Practices in India, are in line with your initiatives introduced by you in India. We have on our team international *safety experts*, totaling safety experience collectively of over 300 Years in various challenging and testing incidents & conditions. The experts have proved their ability in many deadly incidents like in Bhopal gas tragedy, road safety, oil & gas exploration and downstream applications, fire safety & prevention, safety in construction and buildings, including hotels and hospital, chemical industry, pharmaceuticals to name a few.

Each year India is experiencing 500,000 Motor Vehicle Accidents killing 150,000 people and over 3-fold are injured. India recorded 1.6 million fires with 27,027 deaths, every fifth fire-related death in the world in 2017, took place in India. The Indian deaths were 2.5 times the figures in China, where 10,836 people died in fires in 2017 in India. Kids under five and adults above 60 are the biggest fire victims. India has witnessed several major industrial accidents in the past such as the Bhopal Gas Tragedy on the in 1984, releasing approximately 40 tons of toxic methyl isocyanate (MIC) gas, exposing more than 500,000 people to toxic gases resulting in over 25,000 deaths. India has introduced several legislations to avoid such accidents. However, fatal incidents make it to the headlines on a regular basis. For example, the recent fatal gas leak at LG Polymers, 29 major fatal hospital fires in the span of less than three months during peak period of COVID-19, in various cities in India. This only proves the need for education, training and strict enforcement of regulations, and the need for additional control mechanisms in line

with the global industry best practices. In addition, *PRIVATE Third-Party Aud*its, [as opposed to government appointed bureaucrats] will greatly reduce cooking of records by unscrupulous managers and inspectors and will offer verifications of the safety standards' claims made by organizations.

Unfortunately, the prevailing culture is based on production and profitability. Currently, safety standards, policies and procedures exist on paper, but lack implementation and enforcement. Efforts must be made by all parties to IMPLEMENT the standards and make "HSE excellence" their industry goal. Achieving such a goal will take teamwork through education and commitment of workers at all levels, supervisory line-management, policy-making executive management and the HSE professionals.

We are pleased to inform you that on February 01, 2022, J&A HSE Foundation was officially registered. Our *vision* is to have a safe Bharat; our *mission* is to advance occupational safety and health profession amongst the industry, academic institutions, regulatory authority, and other related organizations in India; and our *goal* is to minimize loss of life, livelihood, and property. 

## APPENDIX 1

### GOALS

- **1.** Advance occupational safety and health (OSH) profession amongst the industry, academic institutions, and related organizations.
- **2.** Support and promote OSH as a career choice amongst students by providing guidance, and support through scholarships, as needed.
- **3.** Inspire and develop leaders in HSE practice through globally accredited certifications, enhancing careers, advancing the profession, for protecting people, property and environment.
- **4.** Provide education and developmental opportunities to the deserving individuals extending humanity.
- 5. Recognize individuals, organizations, academic institutions and more, who have made significant contributions, thereby making a difference in the field of HSE, in order to motivate and inspire other HSE professionals, to make similar contributions in saving lives, property and environment.
- **6.** Conduct HSE courses, Training, Auditing, Consultations, Develop Loss Prevention & Health & Safety Programs including Environmental Sciences. To get affiliated with any university/institution/any other local, State or Central Government bodies.

- 7. Build Schools, Colleges and Institution of research in the field of HSE. To establish and conduct College, School and Institution for imparting multifaceted environment that aims to provide technology and nontechnology education in the traditional, modern and scientific manner through its own facility or leased facility, to establish Hostel and Canteen for boarding and lodging to operate Transportation facility for college and hostel.
- 8. borrow, raise money to secure the same, mortgage or lease of the property of the Trust or discharge of any debt binding on the Trust in such a manner as may be thought fit and upon the undertaking and all or any of the movable or immovable property-be created as a security and by mortgage or charges with any nationalized banks or private financial institutions.
- **9.** employ officers, staff, and workers to carry out the objectives of the Trust as well as engage professional and to pay remuneration to them and to appoint, discharge suspend or terminate their services and engagements.
- **10.** erect dwellings for the occupation by employees or other persons to carry out the objectives of the Trust.
- **11.** raise an endowment to encourage the talents by awarding scholarships, prizes, distribution of textbooks, and uniforms for students securing good grades in every academic examination and in furtherance of their studies.

The Foundation shall collaborate with associations having the similar objectives, to promote and carry on the objectives of the Trust [FOUNDATION?], on terms as may be decided by the Board of Trustees and /or enter in agreement with any such organization to achieving the Mission and goals of the Foundation by signing Memorandum of Understanding (MOUs):

- 1. To raise funds by subscriptions, fees, donations, loans from public, Banks, financial institutions, and other means and to hold and manage such funds raised for the above objects,
- **2.** To acquire and to dispose of properties, rights, or privileges necessary or desirable or convenient for the purpose of the Trust.
- **3.** To organize and or conduct seminars, workshops, programs, symposium, guest lectures, events, research, and development.
- 4. To develop specialized skills in promotion of the objectives of the FOUNDATION.
- **5.** To conduct community Development Programs for the upliftment of students, youth, the deprived, aged and infirm of the society and to construct and develop such specialized centers for their welfare.
- **6.** To spread philanthropy, charity, humanitarianism, in the minds of the people, for which organize meetings and seminars.
- **7.** To make such representations to the Union Government, State Government, local and public bodies, in the best interest of the FOUNDATION.

- **8.** To nominate delegates, advisors and persons competent to advance the interests of the FOUNDATION.
- **9.** To receive donations, grants, funds, collect amounts from the associations having similar objectives, trusts, societies, institutions and individuals, foreign bodies, governmental agencies.
- **10.** To purchase or otherwise require either wholly or in part and print publications in newspapers, magazines, pamphlets, journals, reviews, pictorials, annual journals, supplements, books and circulars in furtherance of the above objects.
- **11.** To hold, invest and reinvest any money of the FOUNDATION in such securities or manner as may from time to time be determined and to apply all or any of the funds to advance the objects of the FOUNDATION.
- **12.** To provide food, education, clothing, medical care and other aids to the poor, needy and disabled persons and to afford relief to the people in distress due to natural calamities, accident, famine, flood and epidemics.
- **13.** To improve the level of cleanliness and standards of hygiene in all activities at work and at home, as prevention of diseases and uplifting of the healthcare of all fellow beings.
- **14.** To conduct community development programs for the upliftment of the economically weaker sections of the society and to construct and develop community centers or halls for carrying on such activities.
- **15.** To set-up, open and/or maintain or operate any vocational training centers for the purpose of training up deserving persons in various vocations skills and or trades.
- **16.** To sponsor or support either financially or otherwise, any project of general public utility or community improvement or in the interest of the community, not involving the carrying on of any activity for profit.
- **17.** To support, contribute and/or render assistance, financial or otherwise, to any or all causes of public charitable nature and/or institutions/persons who have objects similar to the objects of the FOUNDATION.
- **18.** The FOUNDATION hopes to offer charitable services to the underprivileged public.
- **19.** J&A HSE Foundation will work hard to raise HSE professionals and support especially the ambitious and most enthusiast but underprivilege youth of India, to achieve their goals.
